4. FIRST-AID MEASURES

First Aid Measures

Eye ContactCauses burns and may result in permanent injury to eyes including blindness.

Immediately flush eyes with water for 15-20 minutes, while holding eyelids open. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

Seek medical attention at once.

Skin ContactCauses corrosive burns. Brief exposure may cause irritation and defatting of the skin.
